All,

We have now received a formal quote from Konnech for the 3 additional PollChief modules. Before Scott begins negotiating with them, we need to make sure which of the modules we would like to pursue and what Fairfax-specific customizations we would need. I believe we had a consensus on acquiring the Asset Management module, but not necessarily the Help Desk module.

Eric, George, Tyrone, Kay, Helen – have you reviewed the Asset Management module? What customizations would you specifically need from the test version to fit your processes? Konnech needs to know this so they can update the quote accordingly.

All – have you tested the Help Desk module? Do you want us to move forward with acquiring it? Do you see anything we should customize?

All,

The test environment for the demoed PollChief modules is available at: <http://demo3.pollchief.com>. If you submitted an NDA last week, please see below for your username and temporary initial password. You should change your password upon first logging in.

On the login screen, you will see some radio buttons for which module to enter. After logging in, you can also switch between modules by using the dropdown menu in the top right of the screen. Here is what they each refer to:

- **PLMS** = Polling Locations module
- **PWMS** = Poll Workers module
- **PAMS** = Asset Management module
- **PCMS**/Poll Call = Help Desk module

As you know, we are mainly considering the Asset Management module and the Help Desk module. I asked the vendor to enable the Polling Locations and Poll Workers modules on the test site so you can see how the data carries over between modules, but we already have licenses for those.

As a reminder, we only have access to this test site until Thursday 5pm.

If you have any questions, especially about how to use PollChief in general, feel free to ask me, Alina, or other members of my team.

I look forward to discussing this further at our meeting today.

All,

Thank you for participating in the demo of the 3 additional PollChief modules – the **Help Desk** module, the **Asset Management** module, and the **Dashboard** module. If you missed it, I have attached copies of the slides provided by the vendor.

Scott suggested we meet promptly to discuss whether we are interested in purchasing these modules, so I have invited you all to a meeting on Monday at 10:30am-11:30am. Before then, please think about each module, whether it would be beneficial to you/your team, and if you believe we should move forward with purchasing it.

Also, on Monday morning, I will send out login information for the test site the vendor has created for us, so you can test and play with these modules for yourself. The test site will be available until next Thursday at 5pm.

PS. If it's helpful to know, we currently pay \$39,375 for the two PollChief modules we currently have – the Poll Worker module and the Polling Locations module. I spoke with the vendor today and they indicated the list price to add the demoed modules are: \$33,000 for the Asset Management module, \$33,000 for the Help Desk module, and \$13,000 for the Dashboard module. (Of course, it's our job to negotiate those prices down!)
