Dear Ms. DeBeauvoir,

I request information as it regards to Pollchief by Konnech Election Management System in Travis County under the Texas Open Records Law Tex. Gov't Code Ann. Secs. 552.001 to 552.353. We respectfully request to be provided with electronic copies of each of the following documents, files, or images, as soon as they become available. You need not wait until the entire request is satisfied before providing documents that are ready for production.

Specifically, I seek the following:

1. Access to and a copy of any and all documents related to the acquisition, utilization, specifications, security, and maintenance of the Pollchief by Konnech Election Management System. Specifically, any related Request For Production Requests, Request for Production Responses, solicitation materials, contracts, sole source certifications, amendments, purchase orders, invoices, technical specifications, user manuals, training collateral, and security certifications.
2. All documents specified by statute to be retained in relation to the Pollchief system and network, either connected directly or indirectly, to Pollchief and Konnech at large.
3. Any and all invoices, correspondence (including emails, memos, and advisories) related to the acquisition, utilization, specifications, security, and maintenance of the Pollchief.
4. All relevant and responsive documents specifically related to how Texas/Travis County uses Pollchief and Konnech and the implementation of the election software system.

If your agency does not maintain these public records, please let me know who does and include the proper custodian's name and address. As provided in the open records law, see Tex. Gov't Code Ann. Secs. 552.221(d) and 231(c). I will expect your response within ten (10) business days (Twenty (20) days if my request requires substantial programming or manipulation of data).

Please provide all information electronically/digitally (PDF Preferred) via email. I agree to pay any reasonable copying and postage fees of not more than \$50 with a receipt provided indicating the charges for each document should they exceed such cost. If the cost would be greater than this amount, please notify me.

If you choose to deny this request, please provide a written explanation for the denial including a reference to the specific statutory exemption(s) upon which you rely. Also, please provide all segregable portions of otherwise exempt material. I would note that willful violation of the open records law can result in the award of court costs and reasonable attorney fees. See § Sec. 552.323.
