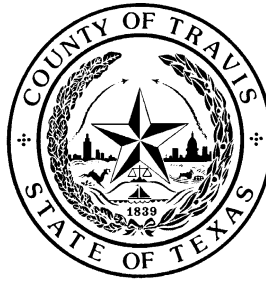

Re: **OR2021-24798**—Request for reconsideration on behalf of third party

Dear Mr. Gordon:

By letter dated July 2, 2021, the Travis County Purchasing Office (“TCPO”) sought an open records letter ruling from your office in relation to a Public Information Act request submitted to TCPO by **Courtney Kramer**, which sought all records relating to election management system “PollChief.” Our correspondence stated that TCPO had notified Konnech, Inc. (“Konnech”), of the request for information and of its right to submit comments to your office explaining why the responsive information is excepted from required disclosure and should not be released by TCPO. On September 9, 2021, your office issued OR2021-24798. TCPO subsequently learned, however, that the third-party notice letter had inadvertently been sent to Konnech’s main office instead of to that of its legal counsel, as Konnech had requested. Due to this error, Konnech’s legal counsel did not learn of the request in time to submit its comments.

TCPO now resubmits the responsive information relating to Konnech and requests that your office reconsider its ruling in order to allow Konnech the opportunity to submit comments. By copy of this letter we are informing the requestor that TCPO has asked for reconsideration of letter ruling OR2021-24798 and has provided a corrected third-party notice to Konnech.
